- If after beginning of Winter peak there are still weekend vacancies, you may book the weekend before or after your booking and pay for only one of the two weekend nights.

Permission and temporary membership form for people under the age of 18

Explanation

This is a permission form to stay at Illawong Lodge and an application for temporary membership of Illawong Ski Tourers Inc. We need this for any person under the age of 18 who wants to stay at Illawong Lodge unless they are accompanied by a parent, legal guardian or caregiver who is a member of Illawong Ski Tourers.

We do not need this form for young people who are immediate family (children or grandchildren) of a member of Illawong Ski Tourers and who stay at the Lodge accompanied by that member. This form can be used for a family of up to 3 young people. Each family will need a separate form.

The following conditions apply:

- *The authorising parent, guardian or caregiver is appointed as a temporary member of Illawong Ski Tourers Incorporated, for the duration of the young person's stay.*
- *The authorising parent, guardian or caregiver nominates a responsible adult resident for each young person for the period of residence. This person is to be the point of adult contact for the young person as required.*

About Illawong Lodge

Illawong Lodge is located several kilometres from the nearest road and services, and in winter is typically inaccessible except by cross country skiing or snowshoeing. Activities undertaken from Illawong may have inherent dangers. Parties in residence may include people known and unknown, sharing a small environment including the same bunkroom, bathroom and living quarters with up to 8 people.

People of all ages and backgrounds, including children and teenagers, are warmly encouraged to stay at Illawong and participate in all its activities – and have done so in safety for over 50 years. Illawong Ski Tourers is known for its culture of providing a child-friendly environment.

All adults responsible for children staying at Illawong should satisfy themselves that the conditions are suitable. Illawong Ski Tourers requires written permission for people under the age of 18 to stay in the lodge without their parent, guardian or caregiver.

Although Illawong is not considered an employer, we use the child-related employment guidelines provided by the NSW Commission for Children and Young People to manage child protection. All residents over the age of 18 are requested to sign a declaration that they are not prohibited by law from working with children, and this is considered when people under 18 will be resident in the lodge.
